**Deadline for Application: November 18, 2017**

1. Application must be completed, signed and notarized. Points not earned until application is completed.
2. \$25 Family Membership dues must be paid. Points not earned until dues are paid.
3. Every contestant is responsible for obtaining a minimum \$100 sponsorship. Families with more than two contestants are responsible for a minimum \$200 sponsorship. Sponsorships are due 11/18/17. Late fee \$30.
4. Minimum requirement of competing in 11 MSLBRA rodeos per event to be eligible for year-end awards in that event.
5. Every family membership is required to work minimum number of rodeos. Work schedule and requirement will be available at the secretary's desk.
6. Each contestant must be a current NLBRA member in good standing.
7. Stalls and RV reservations must be paid by Saturday at 3:00 pm. Late fee \$25 and contestants will not earn state points for that rodeo. The contestant/parent making reservations is responsible for payment.
